

**CAHPS Hospice Survey Top-Box Scores by State
October 1, 2017 through September 30, 2019**

State and national average top-box scores are calculated only among those hospices for which CAHPS Hospice Survey scores are publicly reported on Hospice Compare (i.e., only hospices for which there are 30 or more completed surveys over the eight-quarter reporting period). Hospices are not included in calculation of state or national averages for a measure if there were fewer than 11 respondents for the measure. *State-level variation in CAHPS Hospice Survey scores should be interpreted with caution given the variation across states in the proportion of hospices for which CAHPS Hospice Survey data are reportable.*
